

# ANNUAL REPORT 2015-2016

## A Message from Edward N. Eschbach, President



On behalf of the Foundation of City College of San Francisco, I am pleased to send you the 2016 Annual report. In some ways it has been an *annus mirabilis* for the College!

• On January 13, 2017, the Association of Community Colleges and Junior Colleges, Reaffirmed the Accreditation of City College for 7 years. That reaffirmation was earned by the hard work of the entire CCSF community working, under the leadership of Susan Lamb and Kristin Charles, to redress the issues raised by the ACCJC in 2012.

• There has been a great deal of celebrating and news coverage about the "Free City College" decision announced by Mayor Lee, the Board of Supervisors and the CCSF Board of Trustees. The program provides free tuition for all San Francisco residents. This important and generous benefit will, undoubtedly, make it easier for students to attend CCSF, thereby increasing enrollment. More students mean more funding from the state each year. The importance of the "Free City College" program cannot be over stated.

One thing is very clear: the citizens and leadership of San Francisco are

outstanding supporters of CCSF. The passage of propositions B and W in November demonstrated, without a doubt, that San Francisco STRONGLY supports CCSF.

There remains, however, an important need for scholarships for CCSF students. Even with free tuition, the average student incurs some very significant costs. Books, fees, lab charges, transportation, and room and board, for many, add up. State of California figures indicate that attending CCSF full time can easy cost a student as much as \$18,000 per year.

Fortunately, the generosity and support of the citizens of the San Francisco area for CCSF has continued during fiscal year 2015-2016. The Foundation received contributions of \$ 2,073,000 from individuals, corporations and foundations. That, plus earnings on investment of the foundation's \$17 Million of assets, enabled the Foundation to provide scholarship and other support of \$ 1.7 Million to the students of City College.

One indication of the level of community support is the, always successful, Basic Skills Luncheon put on by the Foundation's Auxiliary. The 2016 Luncheon, with underwriting by Wells Fargo and Chevron, was attended by over 300 ladies and gentlemen and netted nearly \$225,000 for the support of students taking Basic Skills classes and the Guardian Scholars program for former foster children. This year's luncheon, to be held on October 3, 2017 in the beautiful Fairmont

Hotel, will be the 13th annual! Wells Fargo also provided underwriting of CCSF's graduation in May which permitted the Foundation to host a reception for graduates and their friends and family.

On April 22nd the Foundation hosted the Opterra Energy Fairway to College Golf Tournament, sponsored by Opterra Energy Services, at the beautiful city owned Harding Park Golf Course. It was attended by over 100 golfers who played on the famous course and enjoyed a great dinner in the Club House. Netting \$75,000 for scholarships that will be awarded to promising students graduating from San Francisco High Schools, the golf tournament was a clear success.

Once again, on Nov. 13, CCSF and the Foundation celebrated Scholarship Recognition Day when students receive their scholarships and may thank personally the many donors whose gifts have provided the scholarship funding.



The accomplishments of this year were clearly a great team effort with enormous contributions by the faculty, administrative staff and entire CCSF organization which provides a high-quality education for the nearly 70,000 students of CCSF.

Much was accomplished in 2015-2016 and we look forward to your help as we take on future tasks in support of the mission of City College. Thank you for your support of CCSF.

City College of San Francisco made history on January 13, 2017, by receiving reaffirmation of our accreditation for the full seven-year period—the normal renewal cycle for all colleges in the region! Looking forward, we plan to expand our external relationships in the San Francisco community through the hiring of a new Director of Community Development. With many of our challenges behind us, we are excited to continue our

innovative approaches to educating and supporting our students. In particular, the District is making every effort to grow the schedule and increase student enrollment through targeted marketing efforts, strategic partnerships, and market research. Our Enrollment Management Plan features a number of initiatives, including developing a distance learning program and recruiting through new partnerships with city employees, San Francisco Unified School District, the San Francisco Fire Department, and the San Francisco Police Department. As we go forward, our emphasis of course will continue to be on ensuring the success of every student.


I am proud to serve this College along with the hundreds of faculty, staff, and administrators who have dedicated their lives to its success.


